



Ticonderoga Community Childcare Center (Update: December 1, 2023)

Each day the Center comes closer to becoming a reality. Although the January 2024 start has proven to be impossible to achieve, the opening will be as soon as possible in 2024.

Ti-Alliance has been successful in gaining the financial support needed to start the center through a federal grant, generous employers, foundation grants, and donations from individuals and families living in our community.

We are so excited that St. Mary's Parish is partnering with Ti-Alliance to utilize their former school building for the center and they look forward to filling the building with children again. Silver Bay YMCA has been chosen to be the operator of the new Center. As the operator of the teen center at the armory, Silver Bay will be expanding their commitment to Ticonderoga Area families with the new Childcare Center. Ti-Alliance, St. Mary's Parish, and Silver Bay are excited to be bringing public childcare to our community.

Who will we serve? The Center will be serving children from infant to 5 years old.

What's next? While we are completing some renovations of St. Mary's, we'll be working on licensing, staffing, and setting up the classrooms. Pre-registration of children will help us anticipate how many children we need to accommodate and their ages. This will enable us to plan the final configuration of rooms and provide a priority list for applications.

What is the cost of Childcare? The cost of childcare is based on family income. During the final enrollment we will be helping all families complete the paperwork so that they will receive the maximum-allowed childcare subsidies. In some cases, the subsidies will cover the full cost of tuition. In some cases, it may be partial. At this time, families should enroll with the expectation that appropriate subsidies will be provided.

When will the center open? We're not quite sure - but it will be as soon as possible. We have just brought Silver Bay YMCA on board as the operator and they are beginning the licensing process right away. It usually takes a few months. In the meantime, we will be finishing the small renovations to the school and furnishing the classrooms. With any luck, we will be opening doors early in the spring.

Why should I pre-register? By completing this pre-application you are not committing to attending. However, we will be creating the priority for final enrollment based on the date of pre-applications.
